Introduction

Trimavin ("**Trimavin**" or "**we**") respects your privacy and is committed to protecting it through our compliance with this policy (the "**Privacy Policy**"). This Privacy Policy describes the types of information we may collect from you or that you may provide when you access and use the Trimavin service, including any content, functionality and services offered on or through trimavin.com (the "**Service**") and our practices for collecting, using, maintaining, protecting, and disclosing that information.

This Privacy Policy applies to information we collect:

- through the Service; and
- in email, text, and other electronic messages between you and the Service.

It does not apply to information collected by:

- us offline or through any other means, including on any other website operated by Trimavin or any third party (including our affiliates and subsidiaries); or
- any third party (including our affiliates and subsidiaries), including through any application or content (including advertising) that may link to or be accessible from or through the Service.

Please read this Privacy Policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, your choice is not to use our Service. By registering to use the Service or agreeing to Trimavin's Terms of Use (and by accessing or using the Service), you agree to this Privacy Policy. Information We Collect About You and How We Collect It

We collect several types of information from and about users of our Service, including information:

- by which you may be personally identified, such as name, postal address, e-mail address, telephone number, appraiser license information, financial or tax forms (e.g., a W-9), and credit card information ("personal information");
- that is about you but individually does not identify you; and
- about your internet connection, or your smartphone or other equipment you use to access our Service and usage details.

We collect this information:

- directly from you when you provide it to us;
- automatically as you navigate through the Service. Information collected automatically may include usage details, IP addresses, and information collected through cookies, web beacons, and other tracking technologies; and
- from third parties, for example, our business partners.

Information You Provide to Us. The information we collect on or through our Service may include:

- information that you provide by filling in forms on our Service. This includes information provided at the time of registering to use our Service, submitting an order through the Service, subscribing for a newsletter or other materials made available by Trimavin, registering for training or other webinar available through the Service, or requesting further services. We may also ask you for information when you report a problem with our Service;

- your responses to surveys that we might ask you to complete for research purposes; and
- details of transactions you carry out through our Service (including completed and cancelled transactions) and of the fulfillment of your orders. You may be required to provide financial information before placing an order through our Service.

Information We Collect Through Automatic Data Collection Technologies. As you navigate through and interact with our Service, we may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns, including:

• details of your visits to our Service, including traffic data, location data, logs, and other communication data and the resources that you access and use on the Service; and

• information about your computer, smartphone and internet connection, including your IP address, operating system, and browser type.

The information we collect automatically may include personal information, or we may maintain it or associate it with personal information we collect in other ways or receive from third parties. It helps us to improve our Service and to deliver a better and more personalized service, including by enabling us to:

- estimate our audience size and usage patterns;
- store information about your preferences, allowing us to customize our Service according to your individual interests;
- speed up your searches; and
- recognize you when you return to our Service.

The technologies we use for this automatic data collection may include:

- **Cookies (or browser cookies)**. A cookie is a small file placed on the hard drive of your computer. You may refuse to accept browser cookies by activating the appropriate setting on your browser. However, if you select this setting you may be unable to access certain parts of our Service. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies when you direct your browser to our Service.
- Flash Cookies. Certain features of our Service may use local stored objects (or Flash cookies) to collect and store information about your preferences and navigation to, from, and on our Service. - Web Beacons. How We Use Your Information

We use information that we collect about you or that you provide to us, including any personal information:

Disclosure of Your Information

We may disclose aggregated information about our users, and information that does not identify any individual, without restriction.

We may disclose personal information that we collect or you provide as described in this privacy policy:

- to our subsidiaries and affiliates;
- to contractors, service providers, and other third parties we use to support our business;
- to a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of Trimavin's assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by Trimavin about our Service users is among the assets transferred;
- to third parties to market their products or services to you. For more information, see the section called Choices About How We Use and Disclose Your Information;
- to fulfill the purpose for which you provide it;
- for any other purpose disclosed by us when you provide the information; and
- with your consent.

We may also disclose your personal information:

- to comply with any court order, law, or legal process, including to respond to any government or regulatory request;
- to enforce or apply our Terms Of Use (see the Trimavin web site at Trimavin.com) and other agreements, including for billing and collection purposes; or
- if we believe disclosure is necessary or appropriate to protect the rights, property, or safety of Trimavin, our customers, or others. This includes exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction.

Choices About How We Use and Disclose Your Information

We strive to provide you with choices regarding the personal information you provide to us. We have created mechanisms to provide you with the following control over your information:

- Tracking Technologies and Advertising. You can set your browser to refuse all or some browser cookies, or to alert you when cookies are being sent.
